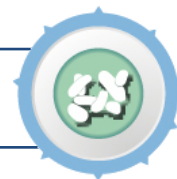

Patch test

Method used to determine whether a specific substance causes any allergic inflammation of the skin. Carried out with an occlusive method, in which patches stay in place for 48 hours.

Test which demonstrates that the product is safe for use and is not at risk of microbiological contamination. It examines the antimicrobial effectiveness of the product on different germs.

Ingredients

Aqua, didecyldimethylammonium chloride, glycerin, peg-40 hydrogenated castrol oil, benzalkonium chloride, (CI 19140), (CI 42090), propan-2-ol.

Physical and chemical properties

pH : 5.5 +/- 0.5
Specific weight : 1000 +/- 10 g/l

Conservation instructions

Keep out of sunlight, heat sources and humidity. Storing temperature should be higher than 10°C and below 35°C.

Intervention in case of contact with eyes or improper use

Contact with eyes: rinse immediately with plenty of water and seek medical advice if the irritation persists.
Ingestion: rinse off the mouth with running water avoiding ingesting the liquid. Get in touch with the closest Poison Centre.

Product life

Product stored according to instructions has a shelf life of 36 months. It must be used within 12 months of opening.
